JUDGMENT ON THE JURY VERDICT

This case was tried before a jury from March 16, 2009, through March 19, 2009.

Present were the following:

Susan Hamm representing the plaintiffs, Michael Welch, Jason Mathew Welsh and Stephanie Catherine Welch; and

Peter T. Dazzio and Chris J. LeBlanc representing Willis-Knighton Pierremont Health Center.

At the conclusion of the trial on March 19, 2009, the jury returned a verdict on written Interrogatory as set forth in the record finding that Willis-Knighton Pierremont Health Center breached the standard of care in its treatment of Linda Welch and the breach caused or contributed to the injuries and death of Linda Welch and the jury awarded damages to all plaintiffs totaling Four Hundred Seventy-Eight Thousand and no/100 Dollars (\$478,000) to be apportioned as follows:

Considering the foregoing:

IT IS ORDERED, ADJUDGED AND DECREED that there be a judgment in favor of Michael Welch, Jason Matthew Welch and Stephanie Catherine Welch and against Willis-Knighton Pierremont Health Center in the amount of One Hundred Thousand and no/100 Dollars (\$100,000) for the pre-death fear, anxiety, pain and suffering of Linda Welch, subject to the maximum limit of One Hundred Thousand and no/100 Dollars (\$100,000) as to Willis-Knighton Medical Center as set forth below.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that there be a judgment in favor of Michael Welch and against Willis-Knighton Pierremont Health Center in the amount of One Hundred Thousand and no/100 Dollars (\$100,000) for the wrongful death

of Linda Welch, subject to the maximum limit of One Hundred Thousand and no/100 Dollars (\$100,000) as set forth below.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that there be a judgment in favor of Jason Matthew Welch and against Willis-Knighton Pierremont Health Center in the amount of One Hundred Thousand and no/100 Dollars (\$100,000) for the wrongful death of Linda Welch, subject to the maximum limit of One Hundred Thousand and no/100 Dollars (\$100,000) as set forth below.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that there be a judgment in favor of Stephanie Catherine Welch and against Willis-Knighton Pierremont Health Center in the amount of One Hundred Thousand and no/100 Dollars (\$100,000) for the wrongful death of Linda Welch, subject to the maximum limit of One Hundred Thousand and no/100 Dollars (\$100,000) as set forth below.


IT IS FURTHER ORDERED, ADJUDGED AND DECREED that there be a judgment in favor of Michael Welch and against Willis-Knighton Pierremont Health Center in the amount of Seventy-Eight Hundred Thousand and no/100 Dollars (\$78,000) for the medical expenses of Linda Welch, subject to the maximum limit of One Hundred Thousand and no/100 Dollars (\$100,000) as set forth below.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Willis-Knighton Pierremont Health Center be and it is hereby declared to be a qualified health care provider in accordance with the meaning of the Louisiana Medical Malpractice Act and that the above Judgment awards as set forth in the six (6) preceding paragraphs, against Willis-Knighton Medical Center be and they are all hereby limited in accordance with the Louisiana Medical Malpractice Act to the total sum of One Hundred Thousand and no/100 Dollars (\$100,000) plus legal interest from the date of the filing of the Patient's Compensation Fund Claim on December 10, 1999, until paid;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Louisiana Patient's Compensation Fund be cast in judgment for all the excess amounts of all judgments awarded over and above the One Hundred Thousand and no/100 Dollars


(\$100,000), plus legal interest from the date of the filing of the Patient's Compensation Fund Claim on December 10, 1999, until paid, on all excess amounts of this judgment over and above the One Hundred Thousand and no/100 Dollars (\$100,000), apportioned to Willis-Knighton Medical Center, and for court costs to be determined by a rule to show cause to be set by this court.
