J U D G M E N T

The consolidated matters captioned above came before the Court for jury trial on May 24, 2010 through May 27, 2010. Considering the Jury Verdict Form No. 1 for the accident of March 17, 2004, signed and dated on May 27, 2010, and considering the Jury Verdict Form No. 2 for the accident of December 8, 2005, signed and dated on May 27, 2010:

IT IS ORDERED, ADJUDGED AND DECREED that there be judgment herein in favor of DELORES CAPUANO and against TARA STEWART and STATE FARM MUTUAL AUTOMOBILE INSURANCE COMPANY in the full sum of FIFTY THREE THOUSAND SIXTY FOUR AND NO/100 (\$53,064.00) DOLLARS plus judicial interest thereon from the date of judicial demand until paid.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that there be judgment herein in favor of DELORES CAPUANO and against JAMES MARKS and UNITRIN PREFERRED INSURANCE COMPANY in the full sum of THIRTEEN THOUSAND TWO HUNDRED SIXTY SIX AND NO/100 (\$13,266.00) DOLLARS plus judicial interest thereon from the date of judicial demand until paid.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that there be judgment herein in favor of DELORES CAPUANO and against ABC AUTO PARTS, LTD, and UNIVERSAL UNDERWRITERS INSURANCE COMPANY in the full sum of TWO MILLION TWO HUNDRED THIRTEEN THOUSAND FOUR HUNDRED THIRTY SIX AND NO/100 (\$2,213,436.00) DOLLARS plus judicial interest thereon from the date of judicial demand until paid.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that court costs and trial costs to be taxed as court costs will be set after a Rule To Tax Costs.


